STEERS TO £1750 HEIFERS TO £1575

An excellent quality show of TB Restricted store cattle reflected in the prices achieved. Trade certainly no less today than in normal Friday markets with strong demand and competition for all consigned. 132 store cattle averaged £1332 overall. Please contact us if you are under TB restrictions and would like some advice on selling store/prime/cull cattle or calves.

CULL CATTLE

Some well fed cows forward and selling to a fast trade comparable to normal Wednesday markets. Friesian cows to 203p/kg and £1397 with others to 193p/kg, 192p/kg and 186p/kg. Continental cows to 189p/kg and topping at £1474 and 192p/kg grossing £1286.

CONTINENTAL STORES

Some excellent quality in the Continental section today selling to a fast trade throughout. OTM Blue x steers from RJ Phillips & Sons to £1750 for a pair. A super consignment of well bred and fed Continental from Hares Partnership saw Limousin x to £1675 (19mo) and Blue x to the same price with others to £1605 and £1595; their Limousin x heifers topped at £1575 and Blue x to £1540 and £1535, with others achieving £1495, £1485 and £1480. Steers with strong frames and potential from W Green & Sons to £1365, £1360 and £1295 from Hayman & Groves. Limousin heifers from JJ Taylor & Son to £1500 and Blue x from DH Masters & Son to £1485.

ANGUS

Angus steers from RJ Phillips & Sons to £1500 (26mo) and £1460 for suckler bred steers (15mo) from JJ Taylor & Son. Large framed steers from R George seeing £1450, steers from W Green & Sons to £1375 and £1365 from AD Mcintosh. Heifers from RJ Phillips & Sons to £1465, well fed heifers from DH Masters & Son to £1455 (twice) and £1450. Medium framed Angus with potential trading between £1205 and £1350 for steers, £1020 and £1320 for heifers.

HEREFORD & SOUTH DEVON

Hereford steers topped at £1530 (31mo) for a pen of 4 from RJ Phillips & Sons. Well grown steers from W Green & Sons to £1475, £1420, £1400 and South Devon to £1385. Heifers from RJ Phillips & Sons to £1435 and £1280 from W Green & Sons.

DAIRY BRED

Some good runs of Dairy x steers with the heavier sorts topping at £1660 (35mo) from RJ Phillips & Sons. Steers from W Green & Sons to £1330 and Fleckvieh to £1155. Holstein Friesians from TR Horsington & Son to £1150 for a pen of 6 and £1130 from AD Mcintosh. Holsteins with good frame and potential to £1068 and smaller steers to £915.

Charolais bull calves to £335 for 1mo and Blues to £250. Hereford bull calves to £290 (3mo) and others to £250. Dairy Shorthorn to £235 (3mo) and £210. British Friesian bull calves to £205 (3mo). Hereford heifers to £230 and Blues to £198. Younger calves trading between £58 for Dairy calves to £200 for the better Native and Continental bred.

A new TB licence (TB16e) has been introduced by APHA (General licence)

TB16e Licence Authorising the Movement of Bovine Animals from Premises under TB Restriction to an Approved Finishing Unit (AFU)/Approved Finishing Unit Enhanced with Grazing (AFUE) or to an Approved Dedicated Sale for TB Restricted Bovine Animals in England or Wales

When the keeper requests a licence to move cattle to a TB dedicated sale (orange market), whenever possible, this new TB16e licence will be issued. It will have a 'valid until date' completed by APHA, and there may be additional conditions. For breakdown herds in Wales, when the next test is the potential clearing test, an additional condition of 'Only valid for calves under 90 days old' will usually be added.

The keeper can copy the original licence as many times as necessary during its validity period. Each time they want to consign cattle to a TB dedicated sale (orange market), the keeper will need to complete Part 2 of the licence with details of the destination premises (i.e., the orange market's name and address) and add the details of the cattle that they will be moving:

- official animal identifier (ear tag number)
- date of birth
- date of last TB test (if a pre-movement test is required, so no need for this to be completed for calves under 42 days old).

The licence must travel with the cattle to the TB dedicated sale (orange market).

The TB16e licence also covers the onward movement of cattle from the orange market to any AFU, AFUE or licensed slaughterhouse. **There is no requirement for the market operator to complete any details for the onward movement from the market, nor does the licence need to accompany the onward movement.**

As a result of this new licence, it is possible that the cattle may enter the TB dedicated sale under the following licences:

- **TB16b** Licence Authorising Movement of Cattle from Premises under Restriction through an Approved Dedicated Sale for TB Restricted Cattle in England or Wales to an AFU/AFUE or a Slaughterhouse. APHA will complete the details of the cattle being licensed and the market operator must complete Part 2 of the licence with details of the onward destination, copying the licence as necessary if a batch of cattle has multiple destinations. This licence needs to travel to the final destination with the cattle.
- **TB16e** Licence Authorising the Movement of Bovine Animals from Premises under TB Restriction to an Approved Finishing Unit (AFU)/Approved Finishing Unit Enhanced with Grazing (AFUE) or to an Approved Dedicated Sale for TB Restricted Bovine Animals in England or Wales.

- **TB208** Licence Authorising Movement of Resolved Inconclusive Reactor Cattle under Restriction Notice (TB197) from an Officially TB Free Herd through a Dedicated Sale to Slaughter/an Approved Finishing Unit/Approved Finishing Unit (Enhanced) with Grazing. The market operator must complete Part 2 of this licence with details of the onward destination and the licence must accompany the onward movement.

Please note that the requirements for pre-movement testing of animals entering a TB dedicated sale remain unchanged:

- calves under 42 days old do not need a pre-movement test.
- animals 42 days old and over must have passed a TB skin test with negative results in the 90 days before movement.
- animals entering the TB dedicated sale from an AFU/AFUE do not need a pre-movement test, unless the originating AFU operator has been informed by APHA that they are non-compliant with the conditions of their AFU's approval. In this case, the animals must have passed a TB skin test with negative results in the 90 days before movement, except calves under 42 days old.
- resolved IRs restricted for life are not required to have a pre-movement test.

Please ensure you are familiar with the Conditions of the new licence. Also attached are the Guidance Notes on the Approval and Operation of TB Dedicated Sales in England and Wales (TB141), which has been amended to include information about the new TB16e licence.

The requirement to forward a schedule of the animals entering the TB dedicated sale (orange market) and the onward destinations to which they are being consigned from the market remains. This schedule must be sent electronically to APHA (CSC.TBmarketreturns@apha.gov.uk in England and APHA.CymruWales@apha.gov.uk in Wales), according to the country in which the gathering takes place, within 24 hours of the end of the sale.
